General Board Meeting Minutes – September 7, 2018

- I. Call to Order- Allison Barkley called the meeting to order at 6:30PM. Allison had all Board of Directors introduce themselves.
- II. StuGo Ashley Fries reported- Homecoming is coming up in 2 weeks and everything is being organized. There is an event planned for everyday leading up to the event with the game on Friday.
